- I. Nomination fee - \$200 paid (Prior to close of nomination date – September 16<sup>th</sup> Junior Teams, September 26<sup>th</sup> Senior teams) No late nominations will be accepted.
- II. Initial Deposit - \$600 One week after team selections completed.
- III. Second payment - \$600 Two months prior to National championships
- IV. Final payment – \$600 revised amount sent via team manager one month prior to national championships.

Note – accommodation and travel will be at own expense amongst the team (Senior teams so above dollar values will vary)

3. Players must return and/or respond to all correspondence on or before the due date, as specified in the correspondence by the team coach or manager.
4. All players are responsible to the management team, consisting of the manager and team coaches. In addition, junior players are responsible to the junior chaperone.
5. All laws of any country a team is visiting must be adhered to.
6. All rules of venues being used by the Tasmanian team and regulations of the host organisation must be adhered to.
7. Players and officials of the management team must not attend training, competition or meetings whilst intoxicated Please note that the drinking of alcohol by juniors will not be tolerated at any stage during the official tour. The drinking of alcohol by players over 18 is not encouraged and supplying alcohol to juniors is forbidden.
8. Players and officials must not behave in such a way as to bring criticism to the touring party.
9. Players and officials must comply with uniform dress code requirements as set by the TUHA committee and monitored by team management.
10. Players must attempt to maintain themselves in peak mental and physical condition during training and competition.
11. Any illness or injury must be reported to the team coach and/or team management as soon as possible.
12. Players must abide by the Australian sports drug code soon as possible.
13. The team manager has the authority to seek medical attention for and on behalf of the players, if the team manager considers it necessary in the circumstances, and the player (or player's parents if the player is under 18) will be responsible for the cost of such treatment.
14. Players must attend all training sessions when and where reasonably required.
15. Players must abide by training programs set by the team coach.
16. Individual sponsorship can only be displayed when permission has been granted by the TUHA and approved with team management.
17. Permission must be granted to the players by the team management or state team co-ordinator prior to any media contact.

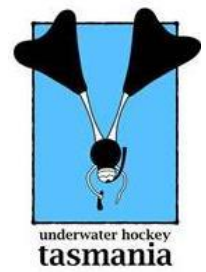
